#### Dossier against Cuban blogger was destroyed, says Administration

A CD delivered to an official of the Presidency within the Cuban Embassy was destroyed as soon as he knew it included the dossier on the Cuban dissident blogger Yoani Sánchez, 37.

The information was given to Folha yesterday by the Secretary General of the Administration, where Ricardo Poppi, who received the material, serves as coordinator of New Media.

This is the third explanation submitted by the agency within four days about the presence of Poppi in a meeting at the Cuban embassy, on February 6, as revealed by "Veja". The meeting discussed the coming of the blogger to the country.

On Saturday, the 16th, the agency said "it was not being informed" about Poppi's participation in a meeting at the embassy "under reported conditions".

In the first communication, the department also did not mention the CD with a dossier against Yoani, basically involving accusations of links with the U.S. government. She is called a "mercenary" by pro-Cuban dictatorship protesters.

Two days ago, the agency acknowledged the participation of the functionary in the meeting, but said it was by coincidence, since he was at the embassy to get a visa. In this second communication, the government says Poppi received the CD, but "made no use of it."
